

City of Melbourne Councillor Gift Register: Current Council term to 30 September 2023

This register is updated quarterly.

The Local Government Act 2020 prescribes that a disclosable gift (being one or more gifts with a total value of, or more than, \$500) does not include the value of any reasonable hospitality received by a Councillor at an event or function that the Councillor attended in an official capacity.

At its meeting on 31 March 2021 Council adopted the Councillor Gift Policy which provides a framework for the management of the offer of gifts, benefits and hospitality and sets the disclosure threshold at the statutory amount of \$500.
