1. Commencement of meeting and apologies

The meeting commenced at 5.30pm.

1.1 Condolence Statement for Jeff Robinson

Council recognises the late Jeff Robinson and his contributions to the City of Melbourne. Jeff passed away in a tragic traffic accident on 7 April 2024.

Jeff was a world renowned leader in sustainable buildings and Global Sustainable Design Expertise Leader at Aurecon, based in Melbourne.

Jeff's energy and commitment for creating a better Melbourne and world was unmatched. He was at every sustainable building industry event asking the tough questions and encouraging the design community, Council and businesses to go faster and be more ambitious.

Jeff contributed his valuable expertise and many hours of strategic advice to the City of Melbourne team developing the Retrofit Melbourne Plan. He will be greatly missed. Our thoughts are with his family and colleagues at Aurecon, and public policy makers across Victoria.

E-Scooter Riding

Anton Diradji asked a question relating to e-scooter riding in the Melbourne CBD.

The Lord Mayor, City Transport Infrastructure Portfolio Lead, thanked Anton for his concerns. The Lord Mayor advised that Council is aware of the problems of illegal riding of e-scooters in the City of Melbourne. While enforcement of illegal riding is the responsibility of Victoria Police, Council officers are working with e-scooter operators to address the problem. Some of the actions include operator patrols to report illegal riding and apply the operators' escalating disciplinary policies which include fines, suspensions and bans, communications to highlight e-scooter rules via social media, e-scooter apps and technology to alert riders if they ride illegally.

The Victorian Government's decision to extend the trial on three occasions for six months each time has made it difficult for Council and the operators to invest in systems to address e-scooter issues. As per Council resolution in August 2023, Council has resolved that if e-scooters are permanently legalised, Council will only support an on-going e-scooter system once the problems of illegal riding are addressed to the satisfaction of the community.

Expansion of Miles and Dodds Street Reserve

Julian Foo asked a question relating to the expansion of Miles and Dodds Street Reserve.

Cr Leppert, Environment Portfolio Lead, advised that this has been covered at a few recent Future Melbourne Committee meetings as there has been a few public questions about the Miles and Dodds Street proposal. At the early stage community consultation, majority of local residents have shown support. There is richer data within the findings of the consultation but Council is yet to make a decision to progress the matter further.

Parking issue in this area has been raised frequently and Council is trying to understand the potential impacts of this project on the local road network and parking capacity. Mid-last year, the Future Melbourne Committee approved the Parking and Kerbside Management Plan which outlines our new, strategic approach to regularly reviewing and adjusting parking controls within a precinct, to manage parking demand. Our approach is not to 'set and forget' parking in an area, particularly after a change within a street. It is a process of continual review and adjustment based on data and feedback from the community.

Approximately \$20,000 has been spent to date on feasibility studies and design. The total project budget is \$2.5 million.

Officers have met with the Proactive Policing unit and Neighbourhood Policing Coordinator specifically to discuss this project and in response to community concerns during stage one consultation. Council is not aware of any existing police reports from the community about the Miles and Dodds Street Reserve on the Community Issues Register. We are engaging with Victoria Police about this matter.

We have requested feedback about Citipower's access requirements and are confident that specific requirements can be resolved during design development.

6.1 Ministerial Planning Referral: TPRM-2023-19, 487-503 Collins Street, Melbourne

The purpose of this report was to advise the Future Melbourne Committee of a Ministerial Planning Application seeking approval for the development of land at 487-503 Collins Street, Melbourne (refer to Locality Plan - Attachment 2 of report from management).

 - 1.1. *Condition 1 c) amended to read "A note on the floor plans specifying the through link is open to the public during the hours of 7am to 7pm, 7 days per week."*
 - 1.2. *Condition 36 amended to read "The through link must provide public access between Collins Street and Flinders Lane during the hours of 7am to 7pm, 7 days per week unless with the prior written consent of the Responsible Authority and Melbourne City Council and except when required to be closed for maintenance."*

6.2 Amendment GC187 Port of Melbourne Planning Scheme Boundary

The purpose of this report was to seek approval for the City of Melbourne's response to Planning Scheme Amendment GC187, which has been prepared by the Minister for Planning.

 - 1.2. *Provides consent under Section 6(6)(d) of the Planning & Environment Act 1987 for the Port of Melbourne Planning Scheme to operate within the City of Melbourne municipal boundary for the relevant sites proposed in Amendment GC187 except for the area that is both north of the south bank of the Yarra and west of the Bolte Bridge (the excluded land).*
 - 1.3. *Indicates that Council or this Committee may further consider the status of the excluded land upon written confirmation from the State Government of the following:*
 - 1.3.1. *The date by which construction will commence on the reinstatement of the Moonee Ponds Creek shared trail closed by Development Victoria in November 2020;*
 - 1.3.2. *The date by which construction will conclude on the same project;*
 - 1.3.3. *The date by which the Moonee Ponds Creek Implementation Plan and associated initial funding commitments will be published; and*
 - 1.3.4. *The flood mitigation, creek protection and biodiversity principles and objectives that will apply to the mouth and extent of the Moonee Ponds Creek within land leased to the Port of Melbourne when considering any future freight rail development (or any other relevant development).*
 - 1.4. *Requests that the CEO write to the Secretary of the Department of Transport and Planning and the CEO of Development Victoria to give effect to the Council's position.*

1. *That the Future Melbourne Committee:*

- 1.1. *Notes the cessation of the 'accelerated program' of construction of safe cycle infrastructure, with 20.8km of new lanes delivered by Council so far since 2020, for the reason that the Department of Transport and Planning has instructed that it will no longer consider trial and low-cost interventions.*
- 1.2. *Notes the announcement by the State Government of 4 April 2024 that regulations for e-scooters will become permanent, in turn creating a reliance on physically separated cycle lanes to facilitate the safe movement of micromobility modes in addition to cycling.*
- 1.3. *Therefore endorses the updated and re-phased Cycling And Micromobility Infrastructure Program for the period between now and FY2026-27, within the budget limits established in the 2023-24 Budget, as set out in Attachment 2, noting that the program and budget to see out the Transport Strategy 2030 targets beyond FY 2026-27 will be the subject of future Annual Planning and Budget processes.*
- 1.4. *Requests that management make adjustments to the timing of projects inside the Cycling And Micromobility Infrastructure Program as required to ensure the orderly construction and expenditure of the program, including delivering upgrades to cycle infrastructure on routes currently relying on adjustable materials.*
- 1.5. *Requests that management continuously publishes current information about, and updates about changes to the timing and scope of individual projects within, the Cycling And Micromobility Infrastructure Program on the City of Melbourne website.*
- 1.6. *Requests Management publish details on the City of Melbourne's website of the design of, and the materials to be used to construct, the individual projects within the Cycling and Micromobility Infrastructure Program, including where bluestone will be used and where projects will also include greening and other streetscape improvements.*
