# 6.3 Proposed travel by Councillor Kevin Louey: Business Partners Cities Roundtable, Ho Chi Minh City, Vietnam and Kuala Lumpur, Malaysia, 4 to 9 September 2016

The purpose of this report was to seek Council approval for the Chair, Future Melbourne (Economic Development) Committee, Councillor Kevin Louey, to travel to Ho Chi Minh City, Vietnam to participate in the annual Business Partners Cities (BPC) Roundtable (6 to 8 September 2016) and Kuala Lumpur, Malaysia (5 to 6 September) to undertake meetings with current and potential partner organisations in support of Council's international business approach.

- 1. That Council:
  - 1.1. Approves Councillor Louey's participation in the 2016 BPC Roundtable to be held in Ho Chi Minh City and undertake meetings with stakeholders in Kuala Lumpur, Malaysia and travel on 4 to 9 September 2016.
  - 1.2. Approves an amount of \$6365.96 to cover the travel costs of airfare to Ho Chi Minh City, Vietnam and Kuala Lumpur, Malaysia, accommodation and incidentals for Councillor Louey.
  - 1.3. Notes that Councillor Louey will prepare a report to the Future Melbourne Committee or Council within 60 days of return from travel.

  - 1.1 Adopts Planning Scheme Amendment C245 as shown in Attachment 4 of the report from management, subject to:

- 1.1.1 The zone for the Queen Victoria Market to the north of the proposed Public Park and Recreation Zone and Therry Street being Public Use Zone (Schedule 7) rather than Capital City Zone, consistent with the exhibited version of the Amendment (i.e. in a form which rejects Planning Panel recommendation 20).
- 1.1.2 Management ensuring that all language in recommendations from the planning panel relating to built form is reflected in the adopted version of the Amendment.
- 1.2 Submits the adopted Amendment to the Minister for approval.
- 1.3 Authorises the Director City Strategy and Place to make any further minor editorial changes to the Amendment documents prior to submitting to the Minister for Planning for approval.
